If you are concerned about lead in your water, you may wish to have your water tested. 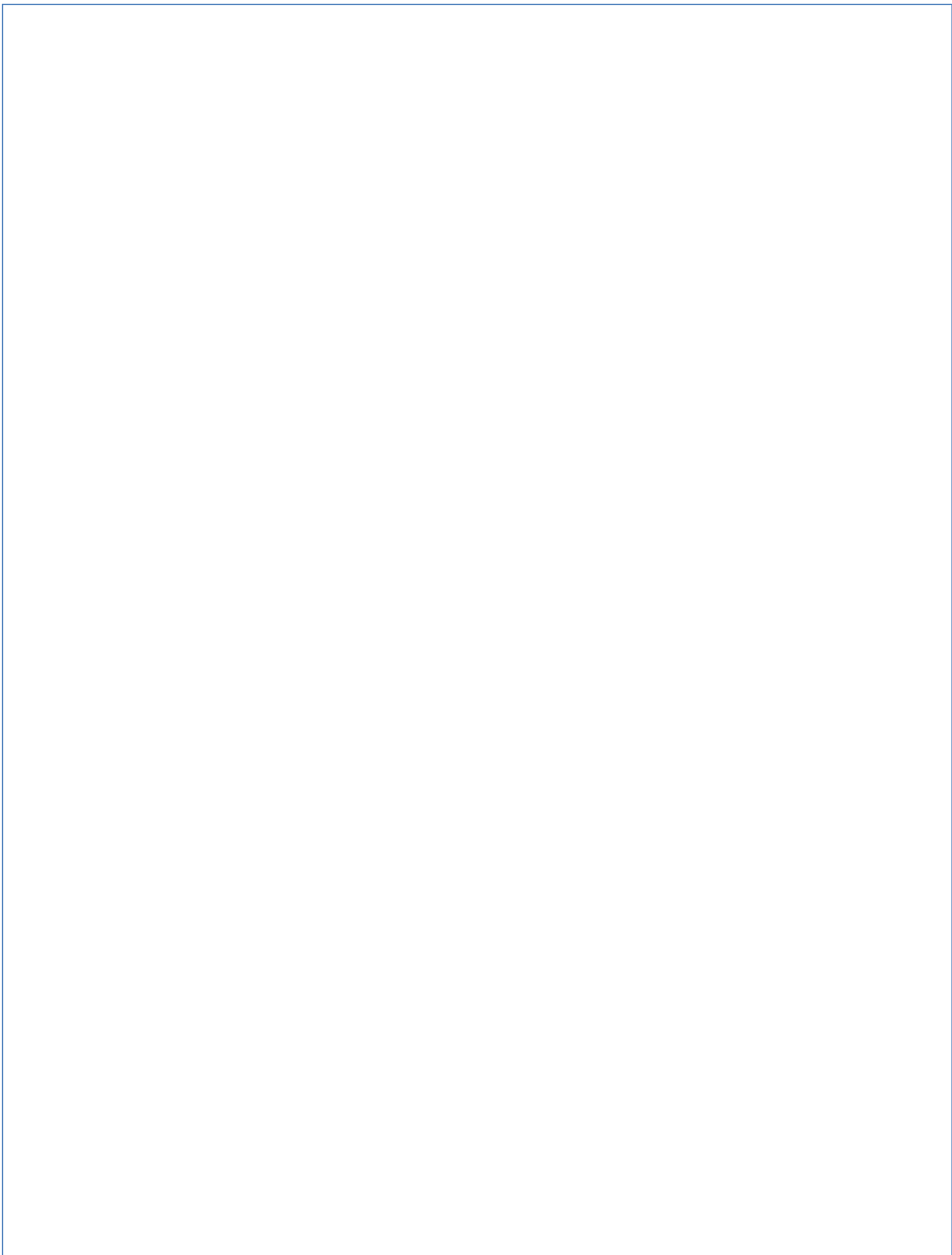
